A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, BEAVER COUNTY, PENNSYLVANIA APPROVING THE LOT CONSOLIDATION PLAN OF LOT PARCEL 65-193-0228.002, KNOWN AS THE HOPEWELL TOWNSHIP COMMUNITY PARK IN HOPEWELL TOWNSHIP, IN ACCORDANCE WITH ZONING ORDINANCE NO. 2004-1 AND SUBDIVISION & LAND DEVELOPMENT ORDINANCE NO.91-2

WHEREAS, an application was submitted to the Hopewell Township Planning Commission by Georgene Duncan to consider a proposed two lot subdivision plan on Laird Drive and Kane Road known as Hopewell Township Community Park formerly known as the Raymond Nemtz Property, Parcel 65-193-0228.002, located in an R-1 District; and

WHEREAS, the Beaver County Planning Commission rendered its comments in a letter dated January 4, 2010 and voiced no objection to the Plan; and

WHEREAS, on January 25, 2010 the Hopewell Township Planning Commission recommended the Plan be reviewed by an independent engineers due to the fact that the Plan had been prepared by the Township Engineer. The Township Engineer joined in the recommendation for an independent engineering review; and

WHEREAS, an independent engineering review was performed by Sleighter Engineering and recommendations issued in correspondence dated March 11, 2010 pursuant to which the Township Engineer implemented all recommendations by Sleighter Engineering; and

WHEREAS, the Hopewell Planning Solicitor Kelly Tocci recommended approval of the application in the letter dated , 2010.



9:35PM **ITEMS FOR DISCUSSION**

Engineer Marie addressed the letter that was sent to the Township from the Airport Area Business Complex listing concerns and problems it would like to have the Township resolve. Marie put together a comprehensive response to all points that were listed. The only outstanding points would be painting a center line and addressing additional lighting in the business park. Letter would be sent by the Manager to the owners of the buildings in the business park.

Marie updated the board on the status of the Laird Road landslide and started the process of trying to figure out what went wrong with the original repair. The Board also at this time advised the Manager to send a letter to the School District recommending to them that they reroute all school bus traffic that currently uses Laird road from Brodhead to Kane Road to alternate routes in the interest of public safety.

Marie updated during her engineer report that she is still in the process of putting together the updated version of Hopewell Township's revised sewer rules and regulations.

Marie updated the board on the 2009 Road Paving Program repairs, and stated that she has sent a letter to Youngblood Paving requesting that they come back and seal all the center lines in the roads that they paved. Marie also stated that the new paved roads will have reflective cracking in which our Road Department will have to seal.

The Board discussed the Fence agreement between Hopewell School District, Hopewell Township and Hopewell Youth Baseball Association. It was determined that additional language was needed to be added to the agreement in regards to length of time. The board will readdress this agreement at its April 26th 2010 meeting.

The review of the sample ordinance for oil and gas drilling was tabled until a future meeting.

The review of the timber and harvesting ordinance was reviewed and will be discussed further at the Boards next workshop.

The manager addressed the paddle boat release of liability forms with the solicitor and expressed the urgency to make sure the solicitor has the forms completed by the next meeting. The forms are needed because the Park pavilion rental season will be in full force in May. The Manager also advised the Board that the Park supervisor will be inspecting, numbering and placing weight limits on the paddle boats in the upcoming weeks.

The Manager discussed with the Board a meeting he had with the President of the Volunteer Fire Department Dan Caton in regards to his Board making sure that Volunteer Fire Department members who are out of work from their regular job due to illness or injury have the proper release documentation before they are allowed to resume any fire fighting functions. Mr. Caton agreed with the Township on this issue.

The manager discussed the results of Hopewell Township's 2009 DCED report with the Board. The Manager explained to the board that both of its major funds the General and Sewer Fund performed better than forecasted and that he hoped the trend will continue for 2010.

President of the Board Mr. Bufalini asked the Board for a motion in regards to proceeding with the stop sign removal and placement of stop signs in the designated beta test site area of the Bradbury Plan. Cost of the removal and placement of the stop signs in this test area were also given as well as concerns for increased speeding in this area by the Police Department if indeed the beta test was to continue. Mr. Bufalini asked a second time for a motion to continue this process. No motion was moved upon. At this point no further action can take place in regards to the beta test area.
